Articles sold by Hawkers in Trains

3222. SHRI RAMANAND TIWARY: Will the Minister of RAILWAYS be pleased to state:

- (a) whether the Government are aware that a number of hawkers sell articles in the running trains on almost all the routes in the country;
- (b) whether they have been issued licences to do so;
- (c) whether surprise checks are conducted by the railway authorities to see that unhygienic articles are not sold; and
- (d) if so, how many persons have been prosecuted for selling such articles?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE); (a) Yes. on certain routes.

- (b) No, hawking in trains is not permitted.
- (c) Yes, surprise checks are conducted t_0 stop unauthorised hawking on the trains.
- (d) During the year 1976-77, 11,457 unauthorised hawkers selling various articles were prosecuted.

Electrification of Adra-Kharagpur line (South Eastern Railway)

3224. DR. BIJOY MONDAL: Will the Minister of RAILWAYS be pleased to state:

- (a) whether there is any proposal or project for electrification of the railway track between Adra and Kharagpur in the South-Eastern Railway;
- (b) if so, by what time the work is likely to start and the likely time for completion of the work; and
- (c) what are the reasons that this track is left out so far in so far as the electrification of the railway track is concerned?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): (a) No.

(b) Does not arise.

(c) Traffic density on the Adra-Kharagpur section is too low to qualify the section for electrification, which is capital intensive. Therefore, the investment in the project is not considered financially justified.

Conversion of Bankura and Rai Nagar Line into Broad Gauge Line (South Eastern Railway)

3225. DR. BIJOY MONDAL: Will the Minister of RAILWAYS be pleased to state:

- (a) whether any decision is being taken or likely to be taken in connection with the conversion of the narrow gauge railway line between Bankura and Rai Nagar in the South-Eastern Railway; and
- (b) whether there is a proposal for extension of the rail line from Rai Nagar to Tarkeshwar in Eastern Railway at the time of the conversion as referred to in part (a) above?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE): (a) and (b). It is not possible to take up these projects at present on account of paucity of resources.

Short Supply of Raw Material to National Organic Chemical Industries

3226. SHRI K. LAKKAPPA; Will the Minister of PETROLEUM AND CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether National Organic Chemical Industries have pointed out that during the first five months of 1977 the company's turnover has been about Rs. 23.25 crores as compared to Rs. 24.53 crores in the same period last year:

- (b) if so, whether this shortfall in the turnover has been due to short supply of raw material and strikes;
- (c) if so, steps being taken by Government to help the company;
- (d) whether the company has plans to develop indigenous technology and has applied for industrial licences; and
- (e) if so, whether Government have considered their application for issuing the licences?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI H. N. BAHUGUNA): (a) Yes, Sir.

- (b) The short-fall in turnover was caused by Bulk Tank Lorry Operators Strike during the later part of May, 1977 which resulted in ultimate short-fall in production.
- (c) The Company's application for Import of Capital Goods for stabilising production has been cleared by the Capital Goods Committee.
- (d) and (e). The Company has plans to develop indigenous technology for the manufacture of Pasticides. A letter of Intent for its manufacture has been issued to the party.
