

Calcutta on 30th May, 1977 and another engine showed distress on Compressor stages during boroscopic inspection, while on ground, at Bombay, on 13th June, 1977.

(b). The investigations are continuing.

(c) Air travel by Airbus A300 B2 aircraft is quite safe, as air aircraft are released for flight only with engines which have been fully tested and found safe for flight.

Sick Cotton and Oil Mills in Gujarat

3714. SHRI AHMED M. PATEL: Will the Minister of COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION be pleased to state:

(a) the total number of sick cotton and oil mills in Gujarat State as on 31st December, 1975 District-wise;

(b) the number of such mills taken over by Government as on 31st December, 1976 and details of these mills; and

(c) the group to which these mills belong?

THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION (SHRI MOHAN DHARIA:.) (a) to (c) There is no precise criteria to describe a sick mill and as such it is not possible to give any details. No cotton textile or oil mill in Gujarat was taken over between 31-12-1975 and 31-12-1976.

Development of Tourist Spots in Gujarat

3715. SHRI AHMED M. PATEL: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) the places selected for development as tourist spots in the State of Gujarat; and

(b) the steps taken and proposed to be taken by the Centre for the development of these places?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI PURUSHOTAM KAUSHIK): (a) and (b). The places selected for development of tourist facilities in Gujarat during the Fourth and Fifth Five Year Plans were Ahmedabad Gandhinagar, Porbander and Sasangir. The schemes taken up at these places are as follows:-

1. Sound & Light Show at Sabar-mati Ashram, Ahmedabad .	11.84
2. Construction of a Tourist Bungalow at Porbunder .	10.93
3. Construction of Youth Hostel at Gandhinagar	4.07
4. Construction of a Forest lodge at Sasangir	21.60

The Schemes listed at 1, 2 and 3 above have already been completed and commissioned. The Forest Lodge at Sasangir is expected to be commissioned during the current financial year.

Subject to the availability of funds and feasibility study being favourable the India Tourism Development Corporation proposes to construct a 3 star 60-room hotel at Ahmedabad during the Fifth Plan period.
