THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION (SHRI MOHAN DHA-RIA: (a) No licence was issued during 1976-77 for starting vanaspati units in the country.

Increase in deposit_{s of} Nationalised Banks

3718. SHRI P. RAJAGOPAL NAIDU: Will the Minister of FINANCE AND REVENUE AND BANKING be pleased to state:

(a) the percentage of increase of deposits in nationalised banks during 1976-77 as compared to the previous year; and

(b) the steps contemplated to increase the percentage?

THE MINISTER OF FINANCE AND RAVENUE AND BANKING (SHRI H. M. PATEL): (a) The deposits of public sector banks increased by 24.2 per cent during 1976-77 compared to an increase of 20.1 per cent during the previous year i.e., 1975-76.

(b) Banks make continuous efforts to increase their deposits. Besides enlarging their branch network to provide banking services to a larger number of people and to mobilise their savings, public sector banks have devised several schemes to suit the requirements of diverse types of small depositors. Banks are also undertaking purposeful publicity campaigns to make the people aware of the services rendered by the banking system.

Charter of Demands from National Textile Corporation show Room Employees Union

THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND CO-OPERATION (SHRI MOHAN DHA-RIA): (a) to (c). The National Textile Corporation have received a Charter of Demands from the Show Room Employees' Union.

The demands are as under:---

(i) Confirmation of all employees.

(ii) Framing of promotion and recruitment rules.

(iii) Stoppage of deduction of security.

(iv) Regularisation of daily wage employees.

(v) Creation of supervisory posts.

(vi) Employees' participation in marketing activities.

(vii) Recognition of the Union.

(viii) Payment of honus.

(ix) Pay scales and related benefits.

(x) Facilities for purchase of NTC fabrics, drinking water etc.

The Union representatives had approached the Labour Commissioner, Delhi and an agreement since been arrived at between the Union and the Management. While some of the demands have been accepted, some others are under discussion between the NTC and the Employees' Union.
