(a) the total number of employees in the office of Regional Provident Fund Commissioner, Bhubaneswar as on the 1 March, 1982 and as on the 1 March, 1985;

(b) the number of Scheduled Caste and Scheduled Tribe employees amongst them;

(c) whether reservation rules in favour of Scheduled Castes and Scheduled Tribes are being followed and rosters maintained for that purpose;

(d) if so, the reasons for the shortfall, if any, and the steps taken to fill the quota reserved for these communities; and

(e) the number of reserved posts lapsed during this period ?

Revision of Minimum Wages Act

3854. SHRI LAKSHMAN MALLICK :
Will the Minister of LABOUR be pleased to state :

(a) the progress made with regard to the revision of minimum wages in respect of the 27 scheduled employments which were placed before the Wage Advisory Board in its meeting on 9 March, 1984;

(b) whether notifications have been issued for the implementation of the minimum rates of wages;

(c) whether there is any proposal under

Government's consideration to raise the minimum wages in view of the increase in the price index;

(d) what steps Government propose to take to increase the minimum wages being paid to such employees whenever there is an increase in the price index; and

(e) whether Government have formulated any formula in this regard; if so, the details thereof ?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR (SHRI T. ANJIAH) : (a) and (b). No meeting of the Minimum Wages Advisory Board was held on the 9th March, 1984. However, at its meeting held on January 9, 1985 the Advisory Board considered and recommended revision of minimum rates of wages. Notifications in the revision of the minimum rates of wages in respect of 34 scheduled employments were issued on February 12, 1985.

(c) to (e). While revising the minimum rates of wages the rise in the Consumer Price Index Number is taken into account. The formula at present being followed by the Central Government is that whenever there is an increase of 50 Points in the 12-monthly average of the Consumer Price Index Number, the minimum rates of wages are increased in the same proportion as the percentage increase in the Consumer Price Index Number.

Statement-I

The rates in forces upto 31-3-1985 for telecast of Hindi feature films in colour on the National network of Doordarshan and those proposed for future by the Film Industry are as follows :—

2. For "Chitrahaar" programmes telecast on the National network, Doordarshan pays a sum of Rs. 1,000/- for each song and dance sequence included in it. In addition, a royalty of Rs. 3,000/- is also paid for acquiring telecast rights of each sequence. The Film Industry has demanded the following rates for song and dance sequences included in "Chitrahaar" programme telecast on the National network :—

(1) For first telecast : Rs. 10,000/-

(2) For each repeat telecast : Rs. 2,500/-

No decision has yet been taken about the rates of payment effective from April, 1985 for telecast of Hindi feature films and "Chitrahaar" programmes on the National network.

Statment-II

For sponsorship of each half-hour chunk of feature films and "Chitrahaar" programmes telecast on the National network, Doordarshan charges a fee of Rs. 1 lakh. The rates for sponsorship of half-hour chunks of feature films and "Chitrahaar" type programmes from individual Doordarshan Kendras are as follows :—
