

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI V. N. GADGIL) :

(a) Replacement of some of the existing TV transmitters in the country, including those in hilly areas, by higher power transmitters is an approved scheme.

(b) and (c). The coverage of TV transmitters in hilly areas is at times limited due to intervening hills. Enhancing TV coverage in such areas involves the use of a large number of low power translators, provision of which would depend on the availability of resources for this purpose during the future Plan periods.

Schemes under RLEGP received from U.P.

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVELOPMENT (SHRI CHANDULAL CHANDRAKAR) : (a) and (b). The Government of Uttar Pradesh had submitted one project for construction of all-weather roads for villages in 49 districts of Uttar Pradesh during 1985-86 under the RLEGP involving an estimated cost of Rs. 13,590 lakhs. Out of this an amount of Rs. 7,590 lakhs is to be met out of RLEGP funds and the balance Rs. 6,000 lakhs by the State Government. The names of the districts alongwith the amount proposed to be spent in each district out of RLEGP funds is indicated in the attached statement. Approval has already been accorded to this project. In addition to this project work on other projects sanctioned for 1983-84 and 1984-85, which have not been completed, will also continue during 1985-86.

**Setting up of Krishi Vigyan Kendras
in Kumaun Region, U. P.**

(a) whether Krishi Vigyan Kendras are being set up in the rural areas of Kumaun region of Uttar Pradesh; and

(b) if so, whether the towns like Rani-khet Bagestiwari, Choukhutia, Champawat, Whaghat, Berinag and Pithoragarh in

Kumaun region of Uttar Pradesh will be benefited by this scheme and details thereof ?

THE MINISTER OF AGRICULTURE AND RURAL DEVELOPMENT (SHRI BUTA SINGH) : (a) Two proposals for establishment of Krishi Vigyan Kendras in the Kumaun region at Sitarganj and at Haldwani in Nainital district of Uttar Pradesh have been received by the Indian Council of Agricultural Research from the G. B. Pant University of Agriculture and Technology, Pantnagar. If Government of India decides to establish additional Krishi Vigyan Kendras in the Seventh Five-Year Plan, these proposals also can be considered.
