

**Change of category of Flats from
LIG to MIG**

(c) whether new registrations in the desired category have since been made; and

(d) if not, the reasons for delay and the time by which the work is likely to be completed ?

(b) to (d). Out of 203 applications received for change of category, conversion has been allowed in 177 cases and Registration Certificate issued. In the remaining 26 cases, Registration Certificate will be issued on completion of formalities.

**Private sector entry into steel making
industry**

The guidelines for grant of industrial licences for steel making are under review in the light of the projections of demand and availability of steel.

(c) The production from the integrated steel plants has been fully taken into account in the projections of demand and availability.

(d) Proposals have been received from a number of private parties for setting up units of varying capacity and product-mix.
