## Gas based Power Projects in Gujarat

**5029.** SHRI HARIN PATHAK: Will the **Minister of ENERGY** be pleased to state:

(a) whether Union Government had given clearance to some gas based power projects in Gujarat; and

(b) if so, the latest position with regard to supply of gas to these projects?

THE MINISTER OF ENERGY AND MINISTEROF CIVIL AVIATION (SHRIARIF MOHAMMAD KHAN): (a) and (b). The scheme for installation of Combined Cycle Gas Based Plant at Gandhar and Pipavav, with a capacity of 615 MW each, has been techno-economically cleared by the Central Electricity Authority subject to certain conditions. The availability of requisite quantity of gas for the proposed projects is yet to be confirmed.
