- allows:
 - 1. The aggregate amount of all subloans made by IDBI to any single borrower shall not exceed US \$ 30 million equivalent.
 - 2. While IDBI is to pay interest at % over the cost of qualified borrowing of the World Bank payable half-yearly, the proceeds will be on-lent by IDB1 with interest @ 2% over the cost of qualified borrowing of the World Bank, where the sub-borrowers bear the exchange risks or ERAS rates where the exchange risks are charged to the Exchange Risk Administration Fund.
 - 3. The loan carries a commitment charge of ½% p.a. on the undrawn amount of principal from time-to-time, Correspondingly, the sub-borrowers of IDBI pay a commitment charge of 1% p.a. to IDBI.
 - 4. The loan is guaranteed by the Government of India.
 - 5. The loan is repayable by IDBI to the World Bank in 20 years while the sub-borrowers will repay in 15 years to IDBI.
- (c) The projects shall be connected with the establishment, expansion and/or balancing, modernisation and replacement proposals of electronics units and related areas including computer software development, systems integration. know-how, consultancy and precision engineering services.
