and control pollution are undertaken by both the central and state Governments. Studies on atmospheric pollution and its impact on health in Ahmedabad and Bangalore have been undertaken by the Indian Council of Medical Research through National Institute of Occupational Health.

## New Treatment method for Heart Patients

Advances are continuously taking place to treat patients in improved ways and in the process new methods are evolved So far as cardiovascular surgery is concerned, balloon angioplasty is one of the new methods to treat patients with blocked coronary arteries leading to disorders like angina and myocardial infarition. This method has a very high success rate. This facility is now available in a number of hospitals in the country.
