AND TOURISM (SHRI MADHAVRAO SCINDIA): (a) to (c). The traffic potential, commercial viability of the operations, availability of resources and their deployment, fleet availability and plan of operation of scheduled airlines and other such factors relevant to the construction of a new airport do not permit the possibility of a new airport being taken up for construction between Sri Ganga Nagar and Abohar.

Clearance to Telugu-Ganga Project

- **721. SHRI K. RAMAMURTHEE TINDIVANAM: Will the Minister of WATER RESOURCES be pleased to state:**
- (a) whether the Central Water Commission has given the clearance for the Telegu-Ganga Project;
 - (b) if not, the reasons therefor; and
- (c) the time by which the clearance is likely to be given?

THE MINISTER OF WATER RESOURCES (SHRI VIDYACHARAN SHUKLA): (a) to (c). Telugu Ganga Project though techno-economically appraised by the Central Water Commission, its consideration was deterred by the Advisory Committee in April, 1988 as the project had not been cleared from inter-State angle. In order to resolve the Inter-State issues the meeting of the Chief Ministers of Andhra Pradesh, Karnataka and Maharashtra, convened by the then Minster (Water Resources) on 5.4.1990 could not materialise as the Chief Minister of Karnataka informed. that the Chief Ministers would themselves resolve the issues relating to sharing of Krishna waters. The three Chief Ministers met twice in 1990. They are to meet again for consideration of the fourtentative alternative

proposals that emerged during their second meeting.

 - (b) if so, the details thereof; and
 - (c) if not, the reasons therefor?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA): (a) Yes, Sir.

(b) A final decision will be taken only when comparative cost of the three options viz. (i) the main runway be extended by 2000 ft.; (ii) the secondary runway be extended to

9000 ft. and (iii) a new site be selected for the construction of a new airport, are evaluated.

Raising of Market Loans by HCL

THE MINISTER OF STATE IN THE MINISTRY OF MINES (SHRI BALRAM SINGH YADAV): (a) Yes, Sir, Hindustan Copper Limited has taken such a decision.

(b) The requirement of market loans would depend on the investments which are undertaken during the VIII Plan and availability of other sources of finance such as budgetary support, suppliers ' credit, loans from financial institutions etc.

The Company currently estimates the requirement of market loans at around Rs. 230 crores.

The main projects identified are as follows:

- (1) Pollution Control at Khetri Copper Complex and Indian Copper Complex, Ghatsila.
- (2) Khetri Smelter expansion.
