## Completion of Phuhia-darjuya Dam in Bihar

807, SHRI RAM VILAS PASWAN: Will the Minister of WATER RESOURCES be pleased to state:

- (a) whether a large area of districts Darbhanga and Saharsa in Bihar are flood prone areas:
- (b) whether the construction work of eleven K.M. of Phuhia-Darjuya dam in this areas has been laying incomplete due to financial difficulties:
- (c) whether the Union Government propose to give financial assistance; and
- (d) if so, the details thereof and if not, the alternative arrangements proposed to be made for its early completion?

THE MINISTER OF WATER RESOURCES (SHRI VIDYACHARAN SHUKLA): (a) Yes, Sir.

(b) to (d). Construction of embankment from Darjuya to Kotharam is in progress as a plan scheme. But, its extension upto Phuhia does not stand included in the approved scheme. It has been decided that allocation of plan funds for projects in the water sector will be earmarked from the begining of the VIII Five Year Plan. There is a specific plan provision of Rs. 1.5 crores in 1992-93 and Rs. 7.5 crores in the VIII Five Year Plan for this scheme.
