- (b) Indian cottonseed extractions have been rendered uncompetitive in the international market due to a variety of reasons including the high domestic cost of cottonseed, the long term decline in EEC prices caused by a sharp increase in the oil seeds production of EEC, their strict aflatoxin regulations and competition from China, Argentina and Kenya.
- (c) Government have already taken a series of measures to improve policy environment for exports. These measures have been further rainforced by the new import Export Policy, which has come into force with effect from 1st April, 1992 for a period of five years.
