THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTIL-IZERS (SHRI EDUARDO FALEIRO): (a) Though it is not correct to say that the Prices of controlled druts have been increasing rapidly, certain amount of increase is inevitable if availability is to be ensured. The Prices of Price controlled durgs are fixed/revised from time to time in accordance with the Provisions of DPCO, 87 after careful scrutiny of the recommendations of BICP. This mechanism ensures that the Price increase approved is actually correlated with

(b) and (c). Both the drugs are outside Price control and the companies are free to fix the Prices of these formulations on their own, under DPCO, 87. The prices of various brands of formulations based on Ciprofloxacin 500mg and Norfloxicin 400mg in 10's strip vary between Rs. 176/- to Rs. 250/- and Rs. 45/- to Rs. 70/- respectivaly. It is not correct to say that the cost price of 10 tablets of these formulations is Rs. 10/-
