institution is initially given provisional accreditation for a period of two years for conducting a particular level of computer course viz.'O' 'A', 'B' and 'C' level and this is regularised subject to meeting specified academic performance in two consecutive examinations, failing which the accreditation will be wihdrawn. Accordingly, it has been decided to identify and withdraw accreditation of those institutes which have failed to send any candidate for 'O' level examination during the provisional accreditation period of two years. So far, provisional accreditation has been withdrawn in respect of any institute.

Price of Rifampicin

4124. SHRI SWARUP UPADHAYA: Will the PRIME MINISTER be pleased to state:
