#### Spurious IV Fluids

(a) whether spurious intravenous IV fluids have been excluded from the purview of the Drug Price Control Order; and

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI EDUARDO FALEIRO): (a) and (b). Manufacture of spurious medicines, including IV fluids, is an offence under Drugs and Cosmetic Act. IV Fluids have been kept outside price control on the recommendation of the Kelkar Committee.

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPARTMENT OF INDUSTRIAL DEVELOPMENT AND DEPARTMENT OF HEAVY INDUSTRY) (SHRIMAIT KRISHNA SAHI): (a) Since the announcement of the New Industrial Policy, approvals accorded for foreign direct investment total Rs. 42.9 billion till 31st December, 1992.

(b) Sector-wise break-up of the foreign investment is given in the attached Statement-I.

(c) A Statement-II showing country-wise break-up of foreign investment approved during 1990-91 is attached.

(d) and (e). The details of registered companies with foreign participation in equity capital are not maintained in this Minis-

try. However, there existed 103 companies having 40% or more foreign equity participation as on 30th June, 1991.
