UNEMPLOYED HANDICAPPED **PERSONS**

1892. MAJOR D. D. KHANGRIA: Will the Minister of LABOUR be pleased to state:

- (a) the number of handicapped persons registered in various employment exchanges in Himachal Pradesh;
- (b) the number of such persons provided with employment during the last two years;
- (c) the number of reserved posts for hand capped likely to be filled by those employment exchanges; and
- (d) the steps being taken by the Government to fill up these reserved vacancies?

THE MINISTER OF STATE OF THE MINISTRY OF LABOUR (SHRI P. A. SANGMA): (a) The number of handicapped persons registered with various employment exchanges in Himachal Pradesh as on 31-12-1992 not all of whom are necessarily unemployed, as per the available information was 3,736.

- (b) The number of handicapped persons placed in jobs by the employment exchanges in Himachal Pradesh during the years 1991 and 1992 was 28 and 31 respectively.
- (c) and (d) 3% of the civil posts in Group 'C' and 'D' under the Central Government and in Public Sector Undertakings are reserved for the handicapped.

A Special Employment Exchange at Shimla has been functioning to cater to the needs of the hand capped and assist them in gotting suitable employment. A Special Cell for the handicapped has also been opened at Employment Exchange Dharamsala. Three Special Recruitment Drives have been conducted to fill up the backlog of Group 'C' & 'D' vacancies reserved for handicapped in respect of Central M nistries, Central Public Sector Under akings, and Banks, etc. The State Government has also been requested fill up the reserved vacancies for handicapped by conducting Special Recruitment Drives in the State.
