THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPARTMENT OF SMALL SCALE INDUSTRIES AND AGRO AND RURAL INDUSTRIES) (SHRI M. ARUNACHALAM): (a) A statement showing the cumulative number of small scale industrial units registered with different State/UT Directorate of Industries and falling under the purview of Small Industries Development Organisation (SIDO) as on 31st December, 1991 and 1992 is enclosed. the number of units as on 31.3.1993 would be available after the expiry of the year 1993.

(b) The growth in the total number of Registered small scale industrial units during 1991 and 1992 was 8.91% and 9.32% respectively showing that there has not been any decline in the growth of small scale industrial units.
