- (b) if so, the details thereof;
- (c) action taken against the offenders; and
- (d) the steps taken to check such incidents in future?

THE MINISTER OF STATE OF THE MINISTRY OF SURFACE TRANSPORT (SHRI JAGDISH TYTLER): (a) to (c) Nine cases of misuse of DTC buses have come to the notice of the Government. The action taken against the offenders are as under:-

- In 4 cases warning has been issued to the person concerned to be careful in future.
- 2. 3 cases have been dropped.
- 2 cases are under process in DTC.
- (d) Officers and Traffic Supervisory staff have been instructed by the management of DTC that no bus should be diverted from its scheduled route unless in cases of emergency or on the directions of Police Authorities. Non compliance of these instruction will render the persons concerned liable for disciplinary action.

- (b) A 4000 lines Remote line Unit (RLU) parented to Digital Tax is under installation at Bareilly.
- (c) This exchange is likely to be commissioned by December, 94.
- (d) The details are given in the enclosed statement.

All these exchanges have since been commissioned during 1993-94.

# TV Transmitters in A.P.

3780. SHRI RAMA KRISHNA KONATHALA; Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) the number of High Power, Low Power and Very Low Power T.V. transmitters functioning in the Andhra Pradesh and new transmitters sanctioned and their present status of implementation;
- (b) whether the problem of shadow zones at Visakhapatnam received the attention of the Government; and
- (c) if so, the action being taken to overcome the shadow zone problem?

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K.P. SINGHDEO): (a) There are 5 High Power Transmitters (HPTs), 31 Low Power Transmitters (LPTs) and 2 Transposers functioning in the State of Andhra Pradesh. 4 HPTs, 26 LPTs and 5 VLPTs are at various stages of implementation/envisaged to be set up in the State.

(b) and (c) Yes, Sir. A Low Power Transposer at Visakhapatnam provides service to the shadow zones. With a view to improve TV coverage in the hitherto uncovred shadow zones, it has been decided to replace the existing Transposer by a Low Power (300W) TV Transmitter and to shift the existing Transposer to another suitable location.

### Doordarshan Kendra at Hazaribagh in Bihar
