*Translation]***Agricultural Development in Gujarat**

2476. SHRI MAHESH KANODIA: Will the Minister of PLANNING AND PROGRAMME IMPLEMENTATION be pleased to state:

(a) the total funds allocated to Gujarat for agricultural development so far during the year 1993-94;

(b) the amount actually utilised by the State Government;

(c) whether the State Government has sought additional funds during the current financial year; and

(d) if so, the details thereof?

THE MINISTER OF STATE OF THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI GIRIDHAR GOMANGO): (a) and (b). The Planning Commission finalises the sectoral allocations in the Annual Plans of the States in consultation with them in different sectors of development. For the year 1993-94 the approved outlay for agriculture and allied activities is Rs. 126.26 crores. The revised outlay for 1993-94 is Rs. 110.54 crores.

(c) Planning Commission have not received any request from the Government of Gujarat for additional amount for current year.

Assistance to Small Scale Industries in Andhra Pradesh

2478. SHRI DATTATRAYA BANDARU: Will the PRIME MINISTER be pleased to state:

(a) whether the Government of Andhra Pradesh have made any request to the Union Government to increase the Central assistance during the current financial year to develop small scale industries in the State;

(b) if so, the details thereof; and

(c) the reaction of the Union Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPARTMENT OF SMALL SCALE INDUSTRIES AND AGRO AND RURAL INDUSTRIES)

(SHRI M. ARUNACHALAM): (a) to (c). Government of Andhra Pradesh have requested to consider the issue of raising the Central Assistance during the year 1994-95 under the Scheme of District Industry Centre of 50:50 ratio instead of lumpsum of Rs. 4 lakhs per District Industry Centre as the expenditure on each District Industry Centre was around Rs. 12.9 lakhs per annum. However, the request could not be considered as the DIC Scheme has since been transferred to States. Further Government of Andhra Pradesh have submitted three project proposals under the Scheme of Integrated Infrastructural Development. One project at Udamalpuram of Kurnool District has been sanctioned involving a total cost of Rs. 328.18 lakhs.

Centrally Sponsored Schemes in Andhra Pradesh

2479. SHRI RAMA KRISHNA KONATHALA: Will the Minister of PLANNING AND PROGRAMME IMPLEMENTATION be pleased to state:

(a) the names of Centrally sponsored schemes for which assistance is being given by the Government to Andhra Pradesh; and

(b) the details of the assistance given during 1991-92, 1992-93 and 1993-94?

THE MINISTER OF STATE OF THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI GIRIDHAR GOMANGO): (a) and (b). Centrally Sponsored Schemes are formulated by the Central Ministries/Departments in consultation with the State Governments/UTs and are implemented by the State Governments/UTs. The Planning Commission does not have

any direct role in their implementation or monitoring. It, however, generally reviews the implementation of Plan schemes during the Annual Plan discussion with the States/Union Territories.

Water Supply to Hyderabad

2480. SHRI DHARMABHIKSHAM: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether the proposal to bring the Krishna river water to the twin cities of Hyderabad and Secunderabad for augmenting the supply of drinking water has been cleared by the Planning Commission;

(b) if so, the details thereof; and

(c) the stage at which the construction stand at present and the funds spent?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT AND MINISTER OF STATE IN THE MINISTRY OF WATER RESOURCES (SHRI P.K. THUNGON): (a) Yes, Sir.

(b) A Project Identification Report on Augmentation of drinking water supply to the twin cities of Hyderabad and Secunderabad from Nagarjuna Sagar at an estimated cost of Rs. 640 crores submitted by the Government of Andhra Pradesh has been posed for World Bank assistance.

(c) The Project is still at the identification stage and therefore, the question of construction work *vis-a-vis* spending of funds does not arise at present. The State Government is engaged in water source dependability
