- The Ministry of Rural Development will prepare separate guidelines for Desert Development Programme for both Hot and Cold desert areas.
- Training facilities to be augmented for imparting training to Government officials, field functionaries, NGOs, etc.

Jawahar Rozgar Yojana

2487. SHRI SHIVLAL NAGJIBHAI VEKARIA: Will the PRIME MINISTER be pleased to state:

- (a) the details of the progress made so far under Jawahar Rozgar Yojana in the rural, backward and tribal areas; and
- (b) the funds provided for this scheme under the Eighth Five Year Plan and in the current financial year, separately?

THE MINISTER OF STATE IN THE MINISTRY OF BURAL DEVELOPMENT (DEPARTMENT OF RURAL DEVELOP-MENT) AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI RAMESHWAR THAKUR): (a) The Jawahar Rozgar Yojana (JRY) is a wage employment programme providing casual manual work to the unemployed and under-employed rural poor. The programme is being implemented w.e.f. 1.4.89 in all the village panchayats in the country including the backward and tribal areas. With a view to providing additional employment to the rural poor living in backward areas, JRY has been intensified during 1993-94 in 120 selected backward districts in different States in the country where there is concentration of umemployment and under-employment.

As per reports received from the States/UTs so far, since the inception of scheme in 1989-90 till June, 1994, 4436 million mandays have been generated under JRY, incurring an expenditure of Rs. 14660 crores.

(b) A provision of Rs. 18400 crores for the Eighth Five Year Plan and Rs. 3855 crores for the current financial year have been made for JRY.

Delay in Decision Making in Air Headquarters

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE AND MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) The C&AG, in report No. 9 of 1994 for the period ended March 1993, has pointed out that in 12 cases pertaining to Foreign Purchase Wing of the Air HQrs., extra expenditure of Rs. 126.79 lakhs was incurred due to delay in decision making.

- (b) The Government has analysed these cases. The cases mentioned in the C&AG's report pertain to the period 1988-1993. The delay in these cases was primarily due to non-availability of adequate FFE at that time. Government has since issued instructions to ensure non-recurrence of such delays.
