## Coir Yarn Production

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (DEPART-MENT OF SMALL SCALE INDUSTRIES AND AGRO AND RURAL INDUSTRIES) (SHRI M. ARUNACHALAM): (a) The exact production capacity of Coir yam sector is not available. However, Coir Board is proposing to conduct a study in Kerala to get an accurate assessment of production capacity. Information collected will be placed before the House.

(b) The actual annual demand of Coir yarn is not available. The production of Coir yarn in 1992-93 was estimated at 1,43,900 MT of which 82.700 MT was consumed as Coir yarn in the export and domestic market. The balance of 61.200 MT of Coir yarn was converted into Coir mats and mattings and Rope. In the year 1993-94 the production of Coir Yarn was estimated at 1,53,900 MT of which 88,900 MT were consumed as coir yarn and 65,000 MT was converted into products and rope.

(c) and (d). No, Sir.
