Oil Selection Board, Bihar

1395. SHRI RAM TAHAL CHOUDHARY: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the details of the members in the Selection Board for Bihar:
- (b) whether Government have issued any directives to the Board regarding recommendations to be made for the dealership of petrol;
- (c) if so, whether the recommendations of Board are obligatory;
- (d) the total number of recommendations made by the Board so far for the dealership of petrol in Bihar; and
- (e) the number of recommendations accepted by the Government?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPT. SATISH KUMAR SHARMA): (a) to (e) Oil Selection Boards (OSBs) have been constituted by the Government for selection of dealers/distributors of petroleum products on the basis of interviews of the eligible candidates who apply in response to the advertisements of the Oil Marketing Companies. Recommendations of the OSBs are not referred to the Government for consideration. These are sent by them to the concerned Oil Companies for issue of Letters of Intent. Composition of the OSB for Bihar is as under:

- 1. Justice B. Prasad-Chairman
- 2. Dr. Faguni Ram-Member-I
- 3. Shri Shamim Hashmi-Member-II

Till January, 1995, the OSB (Bihar) has recommended merit panels for 131 retail outlet dealerships.

Central Assistance

On appraisal, it has been found that Sub-Divisional Engineers against promotion quota from the various squrces are in excess of the number of posts worked out for them as per the percentage laid down in the rules.
