Pre-Censorship Advice

- 1517. MAJ. GEN. (RETD.) BHUWAN CHANDRA KHANDURI: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether the Central Board of Film Certification has sought the views of the film industry associations/film producers on the questions of getting pre-censorship advice from the Board before script/lyrics of song sequences are filmed; and

THE MINISTER OF STATE OF THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI K.P. SINGH DEO): (a) and (b) The Central Board of Film Certification has been advised to take up the matter with the film industry associations. The reactions of the Board are awaited.

Crisis Management Team

- 1518. SHRI S.M. LALJAN BASHA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:
- (a) whether the Oil and Natural Gas Corporation has a permanent crisis management team to anticipate blow-outs, fires, various explosions and accidents at its various operations;

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (CAPT. SATISH KUMAR SHARMA): (a) and (b) Yes, Sir. ONGC has a permanent Crisis Management Department and five Regional Crisis Management Teams consisiting of dedicated Officers to carry out fire fighting and blow out control operations.

(c) and (d) ONGC have also set up a Committee to provide further inputs for strengtening the Crisis Management Teams. In addition, they have acquired additional sophisticated equipments for fire fighting and blow out operations.

TV Production Centre, Chandigarh

INFORMATION AND BROADCASTING (SHRI K.P. SINGH DEO): (a) to (d) The foundation stone for the Programme Generation Facility Centre at Chandigarh has been laid on 5.8.1994. However, the implementation of the project has got delayed due to reasons such as delay in getting requisite approval of the building plans from Chandigarh Development Authority and overall resource constraints. A project of this nature takes about 3 years to complete from the date of commencement of civil works at the site.

- (b) No areas have been declared as Scheduled Tribe areas in Tamil Nadu.
- (c) and (d) Area restrictions have been imposed in respect of following Scheduled Tribes of Tamil Nadu:
 - Kammare (excluding Kanyakumari district and Shenkottah taluk of Tirunelvali district).
 - Kanikaran, Kanikkar (in Kanyakumari district and Shenkottah taluk of Tirunelveli district).
 - Kota (excluding Kanyakumari district and Shenkottah taluk of Tirunelveli district).
 - 4. Kurumbas (in the Nilgiris district).
 - Malayali (in Dharmapuri, North Arcot, Pudukottai, Salem, South Arcot and Tiruchirapalli district).
 - Toda (excluding Kanyakumari district and Shenkottah taluk of Tirunelveli district).
 - (e) No, Sir.
