- allowance for these shortages. Some reasonable shortages should be permitted to the societies doing retail business which would cut-down their losses marginally.
- (h) There is a case for an upward revision in the margin on PDS items. If the margins are not revised, the societies undertaking PDS business would, sooner than later go in losses, creating another problems for the State Government to solve. In case it is not possible to increase the margins, the State Government may consider providing some managerial subsidies to the societies.
