and to their satisfaction. The rounds were issued after successful proof testing of both the primer and ammunition rounds in respect of these two versions. Out of these 39,485 rounds supplied, a portion was used. No problems were reported.

A third version of the ammunition known as 125 mm FSAPDS which is a tank armour piercing ammunition was indigenously developed employing the same proof tested primer 'Y'. During the testing of this third version, that is the FSAPDS, an accident took place. Two lives 1 were lost and one tank was damaged.

Investigations revealed that the accident was most probably due to operation called 'beading' not having been carried out during the manufacture of Primer 'Y'. A committee was constituted to further examine all aspects relating to safety from all angles and it recommended that besides beading another operation known as "Three point stabbing" be also performed during manufacture of the primer. The Primer is now being manufactured with these operations and no abnormalities have been reported.

Following the accident, 28,377 unused rounds of the first two versions out of the lot of 39,485 which had been supplied were segregated and taken up for rectification even though in respect of these two versions no problems had been reported.

(c) to (e) Yes, Sir, it is proposed to enhance the Port Capacity during 9th Five Year Plan by around 122 million tonnes. The Foreign investors having necessary clearance from FIPB/Competent. Authority and Registered/ Proposed to register as a company under Indian Companies Act can be considered for Private Sector projects other than pilotage.
