Including a floating dry dock for catering to ships upto 60,000 DWT. No other proposals have been received by the Government.

#### Crack Down on Fundamenalist by pak

(a) whether it is a fact that Pakistan has ignored repeated pleas by several countries to crack down on leading fundamentalist outfits responsible for spreading terrorism in India and other countries; and

(b) if so, the details thereof ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI PRANAB MUKHERJEE) : (a) and (b) Government believe that the issue of Pakistan's continued support to terrorism has been taken up by some countries with Pakistan. However, Pakistan's support to terrorism and subversion continues unabated and is well recognised by the international community. Government have repeatedly urged Pakistan to give up its chosen path of supporting terrorism and subversion.

THE MINISTER OF STATE IN THE MINISTRY OF RURAL AREAS AND EMPLOYMENT (DEPARTMENT OF RURAL DEVELOPMENT) (SHRI UTTAMBHAI HARJIBHAI PATEL) : (a) Integrated Rural Development Programme (IRDP); (ii) Jawahar Rozgar Yojana (JRY); (iii) Employment Assurance Scheme (EAS) and (iv) Accelerated Rural Water Supply Programme (ARWSP) are major Rural Development schemes being implemented by the Centre in various States including Uttar Pradesh. A statement showing the amount spent and the number of people benefitted under these scheme during last 2 years i.e. 1993-94 and 1994-95 is attached.

(b) and (c) No new Rural Development Programme is envisaged at present. The ongoing self employment and wage employment programme will, however, continue to be implemented during the current year.
