Orissa Project, saving in foreign exchange etc. will be known when the project comes up for an investment decision after scrutiny by the appraisal agencies of Government.

Reservations for S.C./S.T. Employees in United India Insurance Company

1362. SHRI THAZHAI M. KARU-NAUITHI: Will the Minister of FIN-ANCE be pleased to state:

- (a) whether it is a fact that the Government of India orders providing reservations for SC/ST employees at the time of appointment, promotion and confirmations have not been followed in the United India Insurance Company, Madras and if so, why;

- (c) is there any proposal to fix responsibility on those who have failed to implement these orders?

Recently, the public sector banks have been advised to endeavour to raise the share of the 'Priority Sectors' in their aggregate credit to the level of 40 per cent over the next five years. They have also been advised to ensure that a significant proportion of this enlarged priority sector credit is provided to the weaker segments of the society who are beneficiaries of the 20 Point Programme.

While no major change has been effected in the definition of pricrity sectors, it is kept under continual review to be in consonance with the changing requirements of the economy.
