institutions themselves have been operating the bridging finance scheme as part of their normal operations in order to avoid delay in the disbursement of loans and to facilitate drawal of assistance under the Soft Loan Scheme. Bridge loans are being extended generally upto 80 per cent of the loan assistance.

- (c) No. Sir.
- (d) Does not arise.
- (e) The Soft Loan Scheme is being operated by the Industrial Development Bank of India in participation with the Industrial Finance Corporation of India and the Industrial Credit and Investment Corporation of India. The pace of sanctions and disbursements under the Scheme has increased over the years. Units in the jute industry have not, however, taken full advantage of the Scheme.

## Ban on Export of Rhesus Monkeys to USA

- (a) whether the export of rhesus monkeys from India to USA for experimental purposes had been banned in 1978 on grounds of preventing cruelty to animals;

(c) The Governments of importing countries given an undertaking that the monkeys imported from India would be used only for bio-medical research purposes and production of polio vaccines.

## Purchase of Boeing-747 Aircraft
