(ग) टर्बो-प्रॉप विमान-बेड़े की मौजूदा तंग स्थिति के रहते हुए दिल्ली तथा जबलपुर के बीच एक दैनिक विमान सेवा प्रदान करने पर विचार करना संभव नहीं है। इसके अलावा, उपर्युक्त सैक्टर पर यातायाग की माग में भी एक दैनिक सेवा का औचित्य सिद्ध नहीं होता।

Financial involvement of State Government of Orissa in introducing Crop Insurance

1403. SHRI CHINTAMANI JENA: Will the Minister of FINANCE be pleased to state:

(a) what is the financial involvement of the State Government in introducing crop insurance, allowances to the unemployed and of declaring the primary school teachers as Government servants as committed by the Orissa State Government in the Governor's Address of 1980, before the dissolution of the State Assembly; and

(b) has the State Government examined the proposal with its financial implication and, if so, what is the extent of financial commitment from State exchequer?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JAGANNATH PAHADIA):

(a) and (b). The Governor of Orissa, in his address to the Orissa Legislative Assembly on the 11th February, 1980, stated that the State Government was contemplating a scheme for crop insurance to indemnify the farmers against loss of crop due to natural calamities. He also stated that the State Government was considering proposals for declaring the primary school teachers as Government

servants and for grant of unemployment allowance to the deserving unemployed persons. The details and financial implications of these proposals were not spelt out.

Development at Jaipur in Cuttack District

1404. SHRI ANANDI CHARAN DAS: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) is there any proposal for development of 'Biraja Kshetra' and 'Dasaswamedha Pitha' at Jaipur in the district of Cuttack which is a historic place of Hindu pilgrimage and tourist attraction; and

(b) are Government aware that the people coming from all parts of the country and abroad are experiencing much difficulties for want of communication and accommodation?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KARTIK ORAON): (a) No, Sir.

(b) As the development of facilities at pilgrim centres visited by domestic tourists would primarily be the responsibility of the State Government, the facilities at these places would need to be provided in the State Sector. The State Government therefore is contemplating to construct a Tourist Bungalow at Jaipur. It is understood that regular bus services are available to Jaipur from different parts of Orissa.

Bonds in respect of "National Rural Development" Scheme

1405. SHRI VIRDHJ CHAND JAIN: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that Bonds in respect of 7 (seven) years "National Rural Development" Scheme came into force about one year back are yet
