- (a) whether it is a fact that several institutions in the country had organised Essay competitions on Apartheid and related problems in pursuance of the United Nations International Anti-Apartheid Year 1978-79, last year with financial assistance from the Central Government;
- (b) whether the Social Sciences Research Centre, University of Rajasthan, had also organised essay competition in connection with the Anti-Apartheid year;
- (c) whether it is also a fact that the above Centre has not yet published the result and informed the contestants about the details of the winners of prizes, the panel of judges, neither acknowledged receipts of essays, nor replied to the young participants' letters who submitted entries after a good deal of labour and study; and
  - (d) if so, the reasons therefor?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO): (a) As part of the observance of UN International Anti-Apartheid Year 1978-79, in India, essay competitions on Apartheid were organised in various educational institutions. As implementing agency for the national programme for the Anti-Apartheid Year, the Indian Council for Cultural Relations (ICCR) rendered financial assistance, for the conduct of activi-

ties in connection with Anti-Apartheid Year.

According to the information supplied by the Rajasthan University, in all eleven entries were received under the college essay competition and five entries under the school essay competition; the panel of judges consisted of Justice B. P. Beri and Dr. R. P. Bhatnagar, Reader; the following contestants were adjudged as standing in the merit:
