Wagons for Salt Transportation

Written Answers

2907. SHRI DIGVIJAY SINH: Will the Minister of RAILWAYS be pleased to state:

- (a) how many tonnes of salt is lying at rail heads of Kharaghada, Patdi, Bajano, Helvad and Malia awaiting transportation; and
- (b) whether adequate number of wagons will be provided therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) Net known to this Ministry. However, the demand for wagons registered at these stations is as under as on 20th June, 1980 compared with the position on 20th June, 1979:—

Speed Governors for Public Transports Vehicles

2908. SHRI K. MALLANNA: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

(a) whether it is a fact that recently Delhi Administration has taken a decision that the public transport vehicles plying on inter-city and inter-State routes should have speed governors; and

(b) if so, whether there has been any reduction in accidents since this decision is taken?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH):
(a) Yes, Sir.

(b) The Rule regarding compulsory fitment of speed governors has been notified by Delhi Administration only on 4th June, 1980. It is too early to assess the resultant effect by way of reduction in accidents caused by overspeeding of vehicles.

Public and Private Sector Wagon Producing Units

2909. SHRIMATI KRISHNA SAHI: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the wagon requirements of the Railways are met by the industry set up both in Public Sector and the Private Sector;
- there are 13 units with an annual installed capacity of 30,625 wagons in the Private Sector;
- (c) whether it is a fact that for want of incentive from Railways, only 4 units are under operation in Public Sector; and
- (d) if so, whether Government propose to give incentive to Public Sector to produce more wagons for Railways and gradually reduce the number of Private Sector units?

THE DEPUTY MINISTER IN TILE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) Yes; in addition, capacity in three Railway Workshops also utilised for manufacturing limited number of wagons.

(b) There are at present only four active wagon building units in the Private Sector with an annual installed capacity of 8,600 wagons in terms of four wheelers;

(c) No; at present there are five active wagon building units in the Public Sector. Recently wagon orders have been placed on an additional unit in the Public Sector, thereby raising the number of active units in the Public Sector to six; and

(d) The wagon orders are distributed equitably between the Public Sector and the Private Sector units, having regard to their performance, capacity and the outstanding load; there is no proposal to reduce the number of Private Sector Units.

Conversion of Gandhidham-Bhuj Railway Line

2910. SHRI MOTIBHAI R. CHAU-DHARY: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether Government have received a representation about the demand for conversion of metre gauge line from Gandhidham to Bhuj into a broad gauge line, and
- (b) if so, Government's reaction thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) and (b). Updating the preliminary engineering-cum-traffic survey for the conversion of the existing MG line from Gandhi, dham to Bhuj into BG and extension of the BG line to Lakhpat via Mandvi has been included in the Budget for 1980-81 at a cost of Rs. 3 lakhs. Further action will be taken on receipt of the Report.

US arms supply to India

2911. SHRI JYOTIRMOY BOSU: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether it is a fact that the United States intends to sell arms, etc. worth 32 million dollars to India; and
 - (b) if so, the details thereof?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO) (a) and (b). The U.S. Adminis-

tration has submitted to the U.S. Congress a draft letter of Offer and Acceptance (LOA) for sale to India of more than \$ 25 million worth of TOW anti-Tank Missiles Launchers and Ancillary Equipment. After submission of the draft LOA, the U.S. Congress has 30 calendar days to consider the offer. The offer can be finalised only if a resolution in both Houses objecting to the proposed sale is not introduced and adopted.

Import of Anti-Biotic Drugs from U.S.A.
