THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI JANESHWAR MISHRA): (a) As on 1.4.1997, there were 1006 pertrol/diesel retail outlets in operation in Madhya Pradesh. Another 103 retail outlet dealerships already planned are pending for commissioning.

- (b), (c) and (g) Opening of retail outlets in different parts of the country is a continuous process. Regular surveys are conducted by Oil Industry on its own and also at the instance of Government. Locations found feasible as per volume-distance norms are included in the prospective marketing plan. Accordingly, more retail outlets will be opened in Madhya Pradesh through retail outlet marketing plan 1996-98. Selection of dealers will be made after the selection process is reactivated.
- (d) As on 1.4.1997, there were 84 retail outlets pertaining to SC/ST category. Since there is no reservation for backward classes, information regarding retail outlets pertaining to them is not maintained.
  - (e) Yes, Sir.
  - (f) Does not arise.

## SCs/STs Employees in Ports

794. DR. BALIRAM: Will the Minister of SURFACE TRANSPORT be pleased to state:

- (a) whether benefits of reservation are not being provided to the employees and officers belonging to Scheduled Castes/Scheduled Tribes working at the different ports of the country;
- (b) whether it is a fact that when the employees/ officers belonging to Scheduled Castes/Scheduled Tribes working at Mumbai Port Trust call the attention of the Government in this regard then also no action is taken in this regard;
- (c) whether it is also a fact that SCs/STs Union of Mumbai Port Trust attracted the attention of the Government in this regard but no action has been taken till-date;
  - (d) if so, the reasons therefor; and
- (e) the steps being taken by the Government to provide justice to the SC/ST employees?

THE MINISTER OF SURFACE TRANSPORT (SHRI T.G. VENKATRAMAN): (a) Benefits or reservation are being provided as per rules to the employees and officers belonging to Scheduled Castes and Scheduled Tribes working in all major ports of the country.

- (b) No, Sir. Whenever such representations are received by the Government, they are duly examined and action taken.
- (c) to (e) Representations received by the Government from the Mumbai Port Trust SC/ST & OBC Welfare Association regarding certain grievances of SC/ST employees have been duly examined and Mumbai Port Trust has been advised to implement the relevant Government instructions in this regard.
