FUNDS SPENT UNDER CSR IN ODISHA

QUESTION

2799. SHRI MAHESH SAHOO:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the amount of funds spent under Corporate Social Responsibility (CSR) in Odisha, district-wise during the last five financial years;**
- (b) the details of the companies who have not contributed to local area development under CSR programme; and**
- (c) the amount of funds spent by Public Sector Undertakings in Odisha, district-wise in the last five financial years?**

(a) to (c): All data related to CSR filed by companies in MCA21 registry is available in public domain at www.csr.gov.in. On the basis of annual filings made by Companies in the MCA21 registry, District-wise details of the CSR spent by various public and private sector companies in the State of Odisha last five Financial Years (FY) 2016-17 to 2021-22, is at Annexure-I. Funds spent by Public Sector Undertakings in Odisha, district-wise in the last five financial years is at Annexure-II.

Section 135 (5) of the Act provides that the company shall give preference to the local area and areas around it where it operates. In order to ensure an all India spread of CSR expenditure, the Ministry vide General Circular no. 14/2021 dated 25.08.2021 had clarified that the emphasis on local area is only directory and not mandatory in nature and companies need to balance local area preference with national priorities. It was further clarified that the activities mentioned in Schedule VII are broad based and can be interpreted liberally.
