Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether it is a fact that the Government has approved the second phase of the City Investments to Innovate, Integrate and Sustain (CITIIS) project which is under the ambit of the Smart Cities Mission (SCM) and if so, the details thereof;**
- (b) whether it is also a fact that the CITIIS 2.0 would be implemented in 18 cities in partnership with French Development Agency (AFD), Kreditanstalt für Wiederaufbau (KfW), the European Union (EU) and the National Institute of Urban Affairs (NIUA);**
- (c) whether the project aims at promoting integrated waste management and climate-oriented reform actions and if so, the details thereof;**
- (d) the details of projects undertaken under the SCM till now and criteria adopted to select such cities;**
- (e) the details of the recommendation of States received/accepted/rejected along with the reasons therefor, State/city-wise; and**
- (f) the details of funds sanctioned/spent so far compared to Phase-I project?**

ANSWER

(a) to (f) : Government has approved the 'City Investments to Innovate, Integrate and Sustain 2.0 (CITIIS 2.0)' on 31 May 2023. CITIIS 2.0 has been conceived by the Ministry of Housing and Urban Affairs (MoHUA) in partnership with the French Development Agency (AFD), Kreditanstalt für Wiederaufbau (KfW), the European Union (EU), and National Institute of Urban Affairs (NIUA). The period of the program would be for 4 years, i.e., from 2023 till 2027. CITIIS 2.0 has 3 major components :

Component-1 : Financial and technical support for up to 18 Smart Cities for projects promoting circular economy with focus on Integrated Waste Management.

Component-2 : Support to all States/Union Territories (UTs) to build capacities for Climate action.

Component-3 : Interventions at national level to support scale-up across all cities and towns.

12 cities were selected under CITIIS 1.0 program through a challenge process. Selection was done by an independent Jury through a two-stage assessment process. The scoring of the projects was done on the following parameters: (i) Relevance and Feasibility; (ii) Sustainability; (iii) Innovation and Integration; and (iv) Participatory Approach. The Jury results were approved by the CITIIS Apex Committee under the Chairmanship of Secretary, MoHUA. City-wise details of the twelve projects under the CITIIS 1.0 program are given in Annexure-I.

CITIIS 2.0 has been designed in consultation with the States and Cities. Consultation was held with 100 cities under SCM. Furthermore, a Design Committee was constituted under the Chairmanship of Joint Secretary & Mission Director (SCM), MoHUA. Members of the Design Committee comprised of State and city officials along with representatives from the Ministry and the National Institute of Urban Affairs.

As on 7 July 2023, ₹ 399 crore have been spent under CITIIS 1.0.
