Har Ghar Jal Yojana in Odisha

3628. SHRIMATI RAJASHREE MALLICK:

Will the Minister of JAL SHAKTI be pleased to state:-

- (a) the number of households which have been included under Har Ghar Jal Yojana so far, State-wise, particularly in Odisha, district-wise including Jagatsinghpur;
- (b) the percentage of work which has been successfully completed so far along with the percentage of work which is yet to be completed under the said scheme;
- (c) whether the said scheme has not reached hilly villages in various States of the country yet; and
- (d) if so, the details thereof along with the reasons therefor?

ANSWER

(a) to (d) Since August 2019, Government of India, in partnership with States, is implementing Jal Jeevan Mission (JJM)-Har Ghar Jal to enable every rural household in the country, including those in the hilly areas and the districts of Odisha, to have assured potable water through tap connection.

At the time of announcement of Jal Jeevan Mission, 3.23 Crore (17%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 07.08.2023, around 9.52 Crore additional rural households, including many in the hilly villages in various states, have been provided with tap water connections. Thus, as on 07.08.2023, out of 19.41 Crore rural households in the country, around 12.75 Crore (65.69%) households are reported to have tap water supply in their homes and 6.66 Crore (34.31%) are the remaining. State/UT-wise details are **annexed**.

The State/UT, district & village-wise status of tap water connection in rural households, including those in all the districts in Odisha *inter alia* including Jagatsinghpur, as reported by States/ UTs, is also in public domain and available on JJM dashboard at:
