263. SHRI CHHEDI PASWAN: Will the PRIME MINISTER be pleased to state:

(a) whether the Indian Journalist Association has made any demand to amend the Working Journalist and Other Newspaper Employees (Conditions of Service and Misc. Provisions) Act, 1975 and to abolish the Official Secrets Act, 1923 and to provide constitutional guarantee to the freedom of press; and

(b) if so, the steps being taken by the Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND MINISTER OF STATE IN THE MINISTRY OF WELFARE (SHRI RAMJILAL SUMAN): (a) The Government has not received any written request, in the recent past, from the Indian Journalistic in this regard.

Telecast of Marathi Programmes in Goa

265. PROF. GOPALRAO MAYEKAR: Will the PRIME MINISTER be pleased to state:

(a) the reasons for not telecasting Marathi programmes of Goan artists from Panaji T.V. Centre although Marathi is also equally used for official purpose in Goa; and

(b) the remedial measures proposed in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS AND MIN-ISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI SUBODH KANT SAHAY): (a) and (b). Due to very limited facility for recording and telecasting of programmes, Doordarshan Kendra, Panaji is telecasting a 30 minutes Konkani programme five days a week. This apart, the Kendra relays programmes mainly in Marathi from Doordarshan Kendra, Bombay from 5.30 PM to 7.00 PM and 7.30 PM to 8.40 PM daily. The services of Marathi talents available in Goa are redorded as far as possible at Doordarshan Kendra, Panji and sent to Bombay Kendra for telecast and then relayed to Panji from Bombay. With the present constraints in facilities for recording, Doordarshan finds it difficult to originate Marathi programmes form Panaji Kendra at this stage.
