ments of the Government of India is under consideration. As regards Department of Telecom, there is no scheme of having second time bound promotion after 26 years. However, the scheme of biennial cadre reviews for relieving the stagnation in technical and allied cadres in Group 'C' and 'D' has recently been approved and is under implementation.

- (b) The second time bound promotion scheme under consideration in the Department of Posts is self-financing. Matching savings will be provided to off-set the extra expenditure.
  - (c) Does not arise in view of the above.

## Indo-Soviet Friendship

1349. SHRIG.S. BASAVARAJ: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether USSR had assured full support to India on Kashmir issue during the Prime Minister's recent visit to USSR:
