- (ii) providing adequate water drainage;
- (iii) encouraging conjunctive use of surface and ground water;
- (iv) adoption of suitable cropping pattern; and
- (v) creation of awareness among the farmers for more efficient and judicious use of water through adoptive trials, demonstrations, training programmes and extension efforts.

In other areas, adoption of suitable cropping pattern, application of soil amendments and drainage are advocated.

Central Agricultural University in Manipur

2654. SHRI YAIMA SINGH YUMNAM: SHRI CHINMAYANAND SWAMI:

Will the Minister of AGRICULTURE be pleased to refer to reply given to Unstarred Question No. 4009 on August 22, 1991 and state the time by which the Central Agricultural University in Manipur is likely to be established.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRIK.C. LENKA): Sir, No decision on the proposal to establish a Central Agricultural University in Manipur has been taken.

Apple Plantation

2655. SHRI GURUDAS KAMAT: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether apple plantation in the country remains unprofitable activity for farmers;
 - (b) If so, the reasons thereof; and

(c) the steps taken/proposed to be taken to make it profitable profession?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI MULLAPPALLYRAMACHANDRAN): (a) No report has been received about the unprofitability of the apple plantations in the country.

(b) and (c). The Government of India implements the Market Intervention Scheme on the specific request of State Governments whenever there is an apprehension of distres sales by farmers. The State Governments have also to convey their willingness to bear 50% the cost of Market Intervention Operations.

Linkage to Diesel Power Generating Units in Kerala

2656. PROF. K.V. THOMAS; Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the Government of Kerala has requested for oil linkage to diesel power generating units at Brahmapuram. Calicut and Kasar Godu in Kerala; and
 - (b) if so, the action taken thereon?

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRIB. SHANKARNAND): (a) and (b). It has been decided to give a clearance in principle to provide the oil linkage to these projects.

New Passport Offices

2657. KUMARI PUSHPA DEVI SINGH: SHRI CHANDRESH PATEL: SHRI HARIBHAI PATEL:

Will the Minister of EXTERNAL AF-FAIRS be pleased to state the number of new passport offces proposed to be opened in the country during 1992-93, State-wise and location-wise? THE MINISTER OF EXTERNAL AF-FAIRS (SHRI MADHAVSINH SOLANKI): A proposal to open new Passport Offices during 1992-93 is under consideration. The number and location will depend on the available additional financial and manpower resources.

Exploration of Oil at Cochin High

2658. SHRI RAMESH CHENNITHALA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state the achievements made in exploration of oil at Cochin High during the last three years?

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI B. SHANKARANAND): Two wells have been drilled so far, but no hydrocarbons have been discovered.

THE MINISTER OF PETROLEUM AND NATURAL GAS (SHRI B. SHANKARANAND): (a) No, Sir.

- (b) Does not arise.
- (c) No commercial oil/gas discoveries has been made so far in Madhya Pradesh.

Development of Pepper Cultivation

2660. SHRI PALA K.M. MATHEW: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether the Government propose to formulate master plan for the cultivation, encouragement and development of pepper in Kerala;
 - (b) If so, the details thereof; and
- (c) the financial assistance proposed to be given to Kerala for development of pepper cultivation?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI MULLAPPALLY RAMACHANDRAN): (a) and (b). There is no specific proposal of formulating a master plan for cultivation, encouragement and development of pepper in Kerala, However, the Government of Kerala has recently prepared a project proposal for pepper development in Kerala at a cost of Rs. 160.92 crores phased over a period of seven years for external assistance. The main components of the project are rehabilitation of existing gardens, area expansion, strengthening of extension activities and research etc. The aim is to achieve a production target of 1.05 lakh tonnes of pepper by 2000 A.D.

(c) The quantum of financial assistance to Government of Government of Kerala for development of pepper cultivation during 1992-93 and 8th Plan (1992-97) has not yet been finalised. However, an amount of Rs. 337.04 lakh has been allocated out of which Rs. 330.30 lakh has already been released during 1991-92 to the Government of Kerala for development of pepper cultivation under the scheme "integrated Proggramme for the development of Spices".

Export of Red Chillies to Shri Lanka

- 2661. SHRI HARIN PATHAK: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether NAFED had suffered huge loss on export of Red Chillies to Shri Lanka;
