The revenue collection in the month of April every year remains low as noticed from revenue collection trend in the past years. However, during April, 1994, the revenue collection has been higher by 20% when compared to revenue collection in the corresponding month of last year *i.e.* April, 1993 when the revenue collection was Rs. 2137.89 crores. The figures of revenue collection, therefore, indicate a significant upward trend during the period March 1 to April 15, 1994 as compared to revenue collection in February, 1994.

- It would be evident from the increase in revenue collections that production and clearance had not been adversely affected during this period.
