Permission for running passenger service on Bombay-Goa line with special vessels

4623. SHRI S.S. GHOLAP : Will the Minister of SHIPPING AND TRANS-PORT be pleased to state :

(a) whether it is a fact that Mughal Line passenger service on Bombay-Goa line is incurring losses for many years;

(b) if so, the total loss incurred thereon;

(c) whether it is a fact that a private company viz. Satyagiri Shipping having 'No Objection' certificate from the State have asked permission to run the said service with special vessels like Catamaran Type Ship and Hovercraft between Bombay and Goa and also Bombay Ferry Service; and

(d) if so, the action taken by the Government thereon ?

THE MINISTER OF STATE OF THE MINISTRY OF SHIPPING AND TRANS-PORT (SHRI Z.R. ANSARI): (a) and (b). The Mogul Line Limited has incurred losses since the Konkan Passenger service was taken over by them in November, 1973. The total loss incurred by them for 1973-74 to 1984-85 amounts to about Rs. 909.63 lakhs.

(c) The Ministry of Shipping and Transport have not received any such proposal from this Company.

(d) Docs not arise.

## Allotment of book stalls to unemployed graduates

## Pending request of Kerala Government for supply of a whole body C.T. Scan

4625. SHRI VAKKOM PURUSHO-THAMAN: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state :

(a) whether any request from the Kerala State for the supply of a whole body C.T. Scan to the Regional Cancer Centre, Trivandrum is pending before Central Government; and

(b) whether Government propose to supply one of the 9 Scanners expected from Government of Japan to the above Centre ?

THE MINISTER OF STATE IN THE DEPARTMENT OF HEALTH (SHRI YOGENDRA MAKWANA): (a) and (b). Yes, Sir. The Government of India in the Ministry of Health and Family Welfare had proposed to the Department of Economic Affairs of the Ministry of Finance to obtain 9 Whole Body CT Scanners from one of the International Agencies as donation. The Government of Japan have since agreed under their Grant Assistance Programme for 1984-85 to donate only 3 Whole Body CT Scanners and the Government of India in the Ministry of Health and Family Welfare, in turn, has already placed an order on the Directorate General of supplies and Disposal to procure 3 Whole Body C.T. Scanners from Japanese manufacturers. These 3 Whole Body C.T. Scanners have already been carmarked for supply one each to K.G. Medical College, Lucknow, Post Graduate Institute of Medical Education and Research, Chandigarh and Cancer Institute; Madras.
