THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI YOGENDRA MAKWANA): (a) Yes, Sir. The Union Government provides short term loans to various States, separately for Kharif and Rabi seasons, for distribution of agricultural inputes viz. Fertilisers, Seeds and Pesticides

- (b) During Kharif 1987 season, an amount of Rs. 6 55 crores has been sanctioned to Orissa as short-term loans assistance. The shorrt-term loan for Rabi 1987-88 (October, 1987 to March, 1988) will be sanctioned later.
- (c) and (d). The short-term loan sanctioned to Orissa during the years 1984-85, 1985-86 and 1986-87 are given below:

such new Central Government offices which directly serve the Ministries of the Government of India and the liason offices of the undertakings should be located in Delhi. Existing offices of the Public Sector Undertakings in Delhi should be encouraged to shift while new offices of the Public Sector Undertakings to the extent these are possible within their operational areas should be set up outside Delhi.

> The works in 11 Mini Mission Pilot Projects (Districts) have already been started from 1.3.87. Impact of Technology Mission is being felt in various parts of India especially in Mini-Mission Pilot Project areas where through scientific source finding approach failure rate has come down considerably. 39 more Mini-Mission Pilot Projects have been identified and approved. Preliminary works in 12 Mini Mission Pilot Projects have been initiated. The work in the remaining 27 Mini-Mission Pilot Projects will start by the end of December, 1987.
