### Raids on Houses of Income Tax Officers

4820. SHRI SOMJIBHAI DAMOR: Will the Minister of FINANCE be pleased to state:

THE MINISTER OF STATE IN THE DEPARTMENTOF EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI B.K. GADHVI): (a) Ten. Detailed information in respect of value of goods and particulars of documents seized in the raids has not been received;

(b) One officer was found 'not guilty'. One Officer has been suspended. Full information regarding the remaining eight officers is awaited;

(c) No case has been filed.

## Cases of Drug Smuggling in April-June 1987

4821. SHRI YASHWANTRAO GADAKH PATIL: Will the Minister of FI-NANCE be pleased to state:

(a) the number of cases of drug smuggling detected during the period April to June, 1987;

(b) the valuee thereof in the international market; and

(c) measures taken to strengthen antismuggling operations in this regard?

THE MINISTER OF STATE IN THE DEPARTMENTOF EXPENDITURE IN THE MINISTRY OF FINANCE (SHRI B.K. GADHVI): (a) to (c). Reports received by the Narcotics Control Bureau indicate that during April to June, 1987, 305 cases of drug smuggling were detected. No precise value of the drugs seized can be determined as the BHADRA 4, 1909, (SAKA)

illicit international market price varies from place to place and time to time, depending upon the purity of the drug, local demand and supply position, place of origin, etc.

The field formations remain vigilant to curb drug smuggling activities. The preventive and intellignece machinery has been geared up an appropriate enforcement measures are taken in co-ordinantion with the Central and State government authorities concerened. A liberalised reward scheme has been announced by the Government under which the Central and State enforcement officers and their informants are entitled to reward for drug seizures.

NARAYANAN): (a) During the last three years, the Cental Leather Research Institute, Madras had developed fifteen processes.

(b) Of these, four processes were licensed against payments and eleven processes were given as technical aid free of charge. All processes except one have been commercialised by industry.

(c) The one process not yet commercialised by industry has been licensed very recently and it takes some time for a process to go into production
