follow only large and or respected does or in susceptible individuals. The side effects include skin eruptions, nausea, vomiting metabolic disturbances, bleeding complications and severe hypersensitivity reactions. Side effects are, however, rather uncommon in the dosage recommended for prevention of heart attacks.

#### Universities which have not implemented New UGC Scales

1545. PROF. P.J. KURIEN: Will the Minister of HUMAN RESOURCE DEVEL-OPMENT be pleased to state:

(a) The names of universities which have not yet implemented the University Grants Commission new scales;

(b) the reason for not doing so; and

(c) the steps being taken by the Centre **in this regard**?

THE MINISTER OF STATE IN THE DEPARTMENTS OF EDUCATIONAND CULTURE IN THE MINISTRY OF HUMAN **RESOURCE DEVELOPMENT (SHRI L.P.** SHAHI): (a) and (b). The Scheme of revision of pay scales was communicated to the State Governments in June 1987 for consideration and adoption. The decision to sanction these scales of pay to the teachers in different Universities has to be taken by the concerned State Govts. According to the information available, the State Govts. of Arunachl Pradesh, Andhra Pradesh, Goa, J & K, Karnataka, Nagaland, Punjab, Rajasthan, Tamil Nadu and U.P. have accpted the scheme in principle, J & K and Karnataka propose to sanction the revised scales to University teachers only. The implemention of the scheme is reported to be under consideration by the State Govts. of Assam, Haryana, Madhya Pradersh, Maharashtra,

Meghalaya, Mizoram and Sikkim. The scheme has ben implemented by the Central Universities.

(c) The Central Government is pursing the matter with all the State Governments.

# Privatisation of Container Berths at Haidia and Madras Ports

1546. SHRI INDRAJIT GUPTA: SHRI SANAT KUMAR MAN-DAL:

Will the Minister of SURFACE TRANSPORT be pleased to state:

(a) whether Government have decided to privatise setting up of container berths and their leasing and handling at Haldia and Madras Ports; and

The Calcutta Port Trust has with the approval of Government issued an advertisement in September, 1987 to ascertain whether private parties are prepared to invest in the setting up of a container berth at Haldia.

(a) whether the Government of Maharashtra has urged Union Government to undertake railway expansion programmes in the backward areas of the State, like Konkan and Marathwada; (b) if so, whether the Railways have taken any action to speedily undertake the expansion programmes in the backward areas of the State; and

(c) the details of the steps taken so far and the results achieved?

THE MINISTER OF STATE OF THE MINISTRY OF RAILWAYS (SHRI MADHAVRAO SCINDIA): (a) Yes, Sir.

(b) and (c).- Conversion of Manmad-Aurangabad section as 1st phase of Manmad-Parli Vaijnath line from MG to BG is in progress. Outlay for this project in 88-89 is Rs. 5 crores. Conversion of Parbhani-Adilabad MG line to BG has been approved but the work has not been commenced due to constraint of resources.

Surveys for new BG lines from Jalna to Khamgaon, Bhokar to Darwha Motibagh have been taken up. No further action can be considered till surveys are completed and reports examined. Survey for Roha-Mangalore line has just been completed. No action can be considered till report is examined.
