Restoration of Passenger Trains Between Jalandhar City and Hoshiarpur

Loss of DTC Vis-A-Vis other State Road Transport Corporations

- 1581, SHRI SURESH KURUP: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) whether among the State Road Transport Corporations, the loss incurred by the Delhi Transport Corporation is much higher than any other Corporation;
 - (b) if so, the reasons therefore; and
- (c) 'the steps taken by Government to reduce the losses?

THE MINISTER OF STATE IN THE MINISTRY OF SURFACE TRANSPORT (SHRI RAJESH PILOT): (a) The Delhi Transport Corporation's working is comparable only with other similar Metropolitan City Transport of Bombay and Madras. Losses per Km. in respect of Delhi Transport Corporation, BEST and Pallavan are paise 219, 161 and 34 respectively.

(b) and (c). The reason for higher loss by Delhi Transport Corporation is due to its lower per Km. passenger fare as compared to in Bombay and Madras.

The fare structure of DTC was revised during February, 1986 to cover a portion of its working losses. To reduce its interest burden, the capital base of DTC was also restructured recently. Some of the other measures to reduce losses in DTC being taken are replacement of overaged buses, development of infrastructural facilities, prescription of norms and targets for various performance parameters, speedy repair/maintenance, economy in fuel consumption
