

Military stations in Una and Hamirpur

4531. PROF. NARAIN CHAND PARASHAR : Will the Minister of DEFENCE be pleased to state :

(a) whether the Government has decided to acquire land to set up Military Stations at Una and Hamirpur in Himachal Pradesh during the current financial year;

(b) if so, the likely date by which the land would be acquired and the Military Stations set up;

(c) whether any plan for the rehabilitation of likely oustees has also been chalked out for their rehabilitation;

(d) if so, the details thereof; and

(e) if not, the reasons therefor ?

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI CHINTAMANI PANIGRAHI) : (a) and (b) No decision has yet been taken to set up Military Stations at Una and Hamirpur during the current financial year.

(e) rehabilitation plan can be worked out only after the displaced families and the extent of displacement have been identified.

Military Station in Hoshiarpur District of Punjab

THE MINISTER OF STATE IN THE DEPARTMENT OF DEFENCE PRODUCTION AND SUPPLIES IN THE MINISTRY OF DEFENCE (SHRI CHINTAMANI PANIGRAHI) : (a) and (b) A suitable site for the military station at Hoshiarpur is yet to be identified in consultation with the State Government. It is, therefore, not possible to indicate any likely date by which the station would start functioning.

Work undertaken by Delhi Civil Defence Directorate

(d) whether there is any proposal under consideration of the Civil Defence Directorate for conducting black-out rehearsal to educate people of Delhi about the dangers of aerial attack and the sound of siren ; and

(e) if so, when and the details thereof ?

THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. CHIDAMBARAM) : (a) Other than setting up of Mohalla Nigrani Committees under the Delhi Civil Defence Directorate for maintaining communal harmony and keeping a watch on suspicious characters, no other task regarding security of people in Delhi has been assigned to them. The Organisation is designed essentially to life, minimise damages and maintain production during and after hostile attack.

(b) Apart from Deputy Divisional Warden and Divisional Warden, only Sector/Deputy/Post Wardens are entitled for free issue of uniform items once in a year.

(c) Black-out exercise, with public participation was last held on 28.11.1971.

(d) At present, on such proposal is under consideration.
