in Cable industry, grain irradiation etc. and for medical applications are also proposed to be developed at the Centre. Research and development programmes in accelerator technology are also being pursued in the Variable Energy Cyclotrone Centre (VECC) at Calcutta and BARC at Trombay.

(b) Plans to expand and strengthen the facility so that it is able to accelerate a veriety of heavy ions, in addition to alpha particles which are currently being accelerated, are under consideration of the Centre. The question of strengthening the facility to increase the energy of the particles is also being looked into.

Site for pressurised heavy water

- 4610. SHRI ATISH CHANDRA SINHA: Will the PRIME MINISTER be pleased to state:
- (a) the progress made so far in detailed design and engineering of 500 MW Pressurised Heavy Water Reactors;
- (b) whether any site in India has been selected for installing 235 MW Pressurised Heavy Water Reactors after Kaiga and Rajasthan Atomic Power Plants 3 and 4;

Manufacture of selected critical and long delivery equipment has commenced for the first two units.

Selection Committee of the Department of Atomic Energy, relating to Northern, Western, Southern and Eastern Electricity regions of the country are under the consideration of the Government.

Central assistance to Maharashtra for tribals
