accounts in respect of sugar mills. The profitability or otherwise of a sugar factory depends upon a variety of factors which include cane availability, technical and managerial competence and certain other factors which are not directly regulated by the sugar policy. However, the Government have been initiating steps to improve the viability of the sugar industry. In view of this, there is no proposal to institute an enquiry into the matter.

Circular Train in Ahmedabad

At the instance of Ahmedabad Municipal Corporation/Ahmedabad Urban Development Authority, the Metropolitan Transport Projects (Railways, Bombay) got a techno-economic feasibility study carried out by Rail India Technical and Economic Services (RITES) for the introduction of a mass rapid transit system for Greater Ahmedabad area. The report was submitted to the State Government in December, 1988. It is for the Government of Gujarat to process this report further.
