- (a) whether there is any proposal to allow travelling from Visakhapatnam to Vijayawada and vice versa by Coramandal Super Fast Express and to issue tickets for this purpose;
- (b) whether there is also a proposal to increase quota of berths for Visakhapatnam in 34 UP Mail. Coramandal Super Fast Express and Godavery Express trains:
- (c) whether Government also propose to introduce reservation of berths for 34 UP

Mail and 45 East Coast express for this station; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF ECONOMIC AFFAIRS IN THE MINISTRY OF FINANCE (SHRI EDUARDO FALEIRO): (a) The Reserve Bank of India has reported that their present data reporting system does not generate the information in respect of bank credit to agricultural labourers. However, the data in respect of out-standing advances-to agriculture by public sector banks for 3 year period ended December 1988 is as under:
