1294. SHRI RAMANAND TIWARY: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the number of Government servants whose services were terminated under MISA and DIR during emergency State-wise and categorywise; and
- (b) the number of persons reinstated as on 31st May, 1977

THE MINISTER OF HOME AF-FAIRS (SHRI CHARAN SINGH): (a) The Maintenance of Internal Security Act and the Defence of India Rules do not provide for the termination of services of any Government servant.

(b) Does not arise.

कर्जा मंत्री (श्री पी० रामचन्द्रन) : कोटा ताप विद्युत् केन्द्र के पुरा हो जाने पर इसकी प्रतिष्ठापित क्षमता 220 मंगाबाट बिजनी की होगी ।

#### Memorandum Submitted by all Jammu and Kashmir Low-Paid Employees Federation

1296. SHRI R. P. DAS: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether the All Jammu and Kashmir Low-paid Employees Federation submitted a Memorandum on Monday the 2nd May, 1977 demanding reinstatement of all suspended employees and release of MISA detenus;
- (b) if so, the action taken to release MISA detenus of the Federation; and
- (c) whether the General Secretary of the Federation has been released from MISA detention?

THE MINISTER OF HOME AF-FAIRS (SHRI CHARAN SINGH): (a) Yes, Sir.

- (b) According to the information furnished by the Government of Jammu & Kashmir all members of the Federation detained under the Maintenance of Internal Security Act, 1971, in the State have been released.
  - (c) Yes, Sir.

#### Fare-Chart in Mini Buses

1297. SHRI KARPOORI THAKUR: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether mini buses in Delhi do not carry any fare chart duly exhibited in the buses;
- (b) whether the conductors of different mini buses on the same route charge different rates for the same distance;
- (c) whether Government are aware that trouble is often created with the passengers who are forced to pay different rates for the same destination on different mini buses;

- (d) if so, what steps are being taken to save the passengers from this harassment; and
- (e) whether there is any proposal to instruct the mini bus owners to compulsorily exhibit fare-rates for all stages at some prominent place in the mini buses?

THE PRIME MINISTER (SHRI MORARJI DESAI): (a) and (e). The Mini Bus Owners operating their buses under D.T.C. control have instructions to display fare-table in the buses. No complaints have been received regarding non-compliance with such instructions by these operators

(b) to (d). The conductors of mini buses are not allowed to charge different fares for the same distance on the same route. However, complaints in this regard are being received occasionally. Whenever any such complaint is received action is taken against the bus owner, under the terms of the agreement, by way of imposition of penalty or even termination of the contract.

## राबस्थान में झालाबाड़ किसे के लिए विकास योजना

प्रवान मंत्री (भी भोरारजी बेसाई) : (क) भीर (ख). ऐसा सूचित किया गया है कि राज्य सरकार ने झालावाड़ सहित राज्य के बार जिलों के लिए मार्गदर्शी भाषार पर 10-वर्षीय (1979-80 से 1988-89 तक) एकीकृत व्यापक जिला योजनाएं तैयार करने का निर्णय किया है।

इस कायंक्रम में जिले की संसाधन सम्पन्नता और उस क्षेत्र के लोगों की विशेष आवश्यकताओं को ध्यान में रखते हुए विशेष विकास योजना तैयार करने की परिकल्पना की गई है। उक्त योजना तैयार करने में स्थानीय लोगों का सहयोग प्राप्त करने की परिकल्पना भी की गई है।

# Loss of Revenue by Calcutta Port Trust Authorities

1299. SHRI SAMAR MUKHERJEE: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

- (a) whether Calcutta Port Trust Authorities had to incur a loss of revenue for Rs. 20 lakhs for delayed revision of rent schedule on Port Estate;
- (b) whether the Public Accounts Committee in its 175th Report suggested for an enquiry to fix up the responsibility and punish the officer responsible for the same; and
  - (c) if so, the action taken so far?

THE PRIME MINISTER (SHRI MORARJI DESAI): (a) to (c). The Public Accounts Committee in its report had suggested in para 1.76 that delay in the revision of the schedule of rents is a serious matter and calls for fixation of responsibility for suitable action against the officers responsible for the loss of revenue to the Calcutta Port Trust.

In this connection, C.P.T. have reported that the Rent Schedule of the Port Trust is revised regularly and since 1955, there have been four such revisions. The revision of the Rent Schedule was deferred only once from April, 1972 to April, 1973. The pro-
