**Frequency of D.T.C. buses on route Nos. 720 and 854**

1359. SHRI KARPOORI THAKUR: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:

(a) percentage of frequency maintained by DTC, Delhi on bus route Nos. 720 and 854 during the month of April 1977;

(b) total number of average daily trips as shown in the time table and total number of average daily trips actually performed by buses on the above routes; and

(c) steps being taken to stick to the time table on these two routes?

THE PRIME MINISTER (SHRI MO. RARJI DESAI): (a) The percentage of the trips operated to the number of scheduled trips on route Nos. 720 and 854 was 78.26 and 92.06 respectively during April, 1977.

(b) Against an average daily schedule of 79 trips on route No. 720, 62 were operated, and against a daily average schedule of 83 trips on route No. 854, 77 were operated, during April, 1977.

(c) While there is some irregular operation of the services on route No. 720, the position on route No. 854 is satisfactory. Main reasons for missing of trips on route No. 720 have been the mechanical failure of buses, hold up of buses in the workshop for major repairs, and delays at the

Nangal Rai Railway Crossing. Every effort is being made by the Corporation to improve maintenance of buses and speed up the repairs of buses off the road for major repairs.

#### Representations from C.I.V. Union, Ahmednagar

1362. SHRI R. K. MHALGI: Will the Minister of DEFENCE be pleased to state:

(a) whether Government have received two representations dated 30th March 1977 and 12th April 1977 from C.I.V. Union, Ahmednagar (Maharashtra);

(b) if so, whether Government have taken any action or propose to take action in regard thereto; and

(c) if so, facts thereof?

THE MINISTER OF DEFENCE (SHRI JAGJIVAN RAM): (a) Yes, Sir.

(b) and (c). 139 posts in various grades have been reduced in the Controllerate of Inspection Vehicles, Ahmednagar, as a result of on-the-spot study by the Establishment Study

Team. The C.I.V. Civilian Employees Union have represented against this reduction. The following steps have been taken to avoid hardship to the staff: Of the 139 persons affected, 76 are being adjusted against existing vacancies in the Establishment. Of the remaining 63, orders for transfer of 26 individuals to Establishments at other Stations of their choice have already been issued. Efforts are being made to adjust the remaining staff in other Units/Stations.
